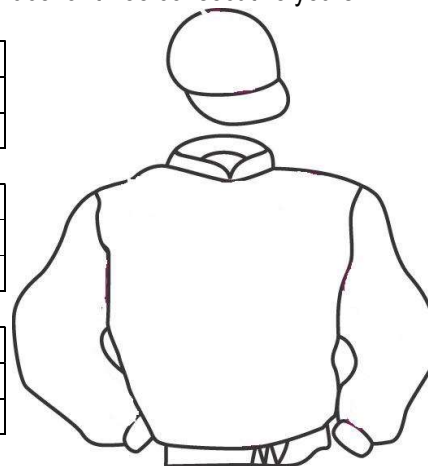

- Diagrams differing from those listed above and previously assigned are still in force, but can only be authorised again at the QREC Stewards discretion.
- Furthermore, the QREC Stewards may allow an owner who has registered their colours abroad, whose racing colours are not matching the standard diagrams, to race under the QREC Rules of Racing with the same colours as the ones registered abroad.
- Subject to QREC Steward's approval, exceptional racing colours, differing from the above diagrams, may be applied for against a fee of QR 2,000.
